Heard the learned counsel on either side.

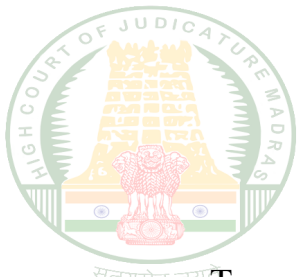
