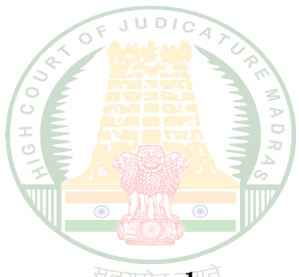

4. On due compliance of this order, the Registry is directed to number the appeal, if it is otherwise in order and list the appeals for admission in the 2nd week of February, 2025.

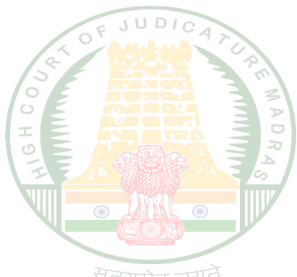
