Heard the parties.

- 2. Petitioners have been made accused in connection with Deoghar (Cyber) P.S. Case No. 97 of 2023 for the offences registered under sections 419/420/467/468/471/120B of the Indian Penal Code and 66(B)/66(C)/66(D)/84(C) of I.T. Act, pending in the court of learned Additional Sessions Judge-II, Deoghar.
- On 27.12.2023 at about 9.30 a.m., Cyber Police, Deoghar received confidential information that cyber criminals had assembled in the village Basbutia and were committing cyber-crime. Police raided different places of occurrence and apprehended the petitioners. Two mobile phones and two debit cards were recovered from the possession of the petitioner Pardhum Kumar Yadav, one mobile phone was recovered from the possession of the petitioner Upendra Mahra, two mobile phones were recovered from the possession of the petitioner Krishna Kumar Das, one mobile phone along with debit card was recovered from the possession of the petitioner Suman Kumar Das, one mobile phone was recovered from the possession of the petitioner Sandip Kumar Yaday, one mobile phone was recovered from the possession of the petitioner Ashok Kumar Das, one mobile phone was recovered from the possession of the petitioner Ramesh Das, one mobile phone along with debit and credits cards were recovered from the possession of the petitioner Dhananjay Kumar Yadav, three mobile phones were recovered from the possession of the petitioner Nasim Ansari, three mobile phones were recovered from the possession of the petitioner Deepak Kumar Das, one mobile phone along with one debit card was recovered from the possession of the petitioner Murtaz Ansari, one mobile phone was recovered from the possession of the petitioner Siraj Ansari and two mobile phones along with one master debit card was recovered from the possession of the petitioner Rayesh Ansari
- 4. Case diary earlier called for has been received.
- Mr. Vineet Kumar Vashistha, learned Special P.P, Mr. Subodh Kumar 5. Dubey, Mrs. Vandana Bharti and other A.P.Ps have appeared on behalf of the State. They have opposed the prayer for bail. They also submit that as far as the petitioners Pardhum Kumar Yadav, Suman Kumar Das, Ashok Kumar Das, Ramesh Das, Nasim Ansari, Deepak Kumar Das, Murtaz Ansari and Rayesh Ansari are concerned, no victim has come forward to say that they were

involved in cyber offence. As far as the petitioners Upendra Mahra, Sandip Kumar Yadav, Ramesh Das, Dhananjay Kumar Yadav are concerned, victims have come forward to say that these petitioners had cheated them or attempted to cheat them.

- 6. Mr. Arvind Kumar Choudhary, learned counsel appearing for the petitioner Ramesh Das, has submitted that no sim card was recovered at the time of his arrest from his possession and as such, it cannot be said that he had attempted to cheat anybody.
- 7. Considering the aforesaid facts, petitioners Pardhum Kumar Yadav @ Pradhuman Kumar Yadav, Suman Kumar Das, Ashok Kumar Das, Ramesh Das, Nasim Ansari, Deepak Kumar Das, Murtaz Ansari @ Mumtaz and Rayesh Ansari @ Rahish Ansari, are directed to be released on bail on furnishing bail bonds of Rs. 20,000/- (Rupees twenty thousand) each, with two sureties of the like amount each, to the satisfaction of learned Additional Sessions Judge-II, Deoghar in connection with Deoghar (Cyber) P.S. Case No. 97 of 2023.
- 8. As far as the petitioners Upendra Mahra, Krishna Kumar Das, Sandip Kumar Yadav, Dhananjay Kumar Yadav @ Dhananjay Yadav and Siraj Ansari are concerned, their prayer for bail stands rejected.
