- 2. In this writ petition, the petitioner has prayed for a direction to grant him promotion to the post of Reader with effect from 1.1.1991 under the Time Bound Promotion of Lecturers and consequently pay the arrears of salary along with interest thereupon.
- 3. At the outset, Mr. Gahlaut, learned counsel for the petitioner, submits that the promotion has been granted to the petitioner but he has been deprived from the consequential benefits arising out of such promotion.
- 4. In view of the fact that the main grievance of the petitioner has been redressed, this writ petition stands disposed of with a liberty to the petitioner to approach the respondent no. 5 by filing a detailed representation claiming the benefits arising out of the promotion granted to him to the post of Reader within a period of three weeks from today and if such representation is filed the respondent no. 5 shall pass a reasoned and speaking order within a period of four weeks from the date of submission of the representation.

- 5. If the grievance of the petitioner is addressed in the affirmative, the matter shall be forwarded to the respondent no. 2 who shall take steps for extending the financial benefits in favour of the petitioner.
