- 1. Having heard learned counsels for both the sides and looking to the order passed by this Court in W.P. (S) No. 3181 of 2008, judgment dated 30th August, 2017 and also looking to the counter affidavit filed by the opposite parties, it appears that legally payable amount has already been paid to the petitioner. The amount of Rs.3,81,000/- was paid earlier and now the amount of Rs.53,000/- has been paid. Thus, legally payable amount, as per the respondents, has already been paid to the petitioner.
- 2. In view of the counter affidavit filed by the opposite parties, there is no willful disobedience by the respondents of the order passed by this Court in W.P. (S) No. 3181 of 2008, judgment dated 30th August, 2017.

- **3.** Nonetheless, if the petitioner is aggrieved by the aforesaid calculation of the payment, the same can be challenged by this petitioner, in accordance with law before appropriate forum.
- **4.** With the aforesaid observations, this contempt application is, hereby, dismissed.
