- 2. It has been submitted by the learned counsel for the appellant that on inquiry, it has come to light that the original Respondent no. 1 apart from being survived by his wife, is also survived by his two sons and daughter-in-law, mention of which has been made at paragraph-6 of the instant application.
- 3. It appears that earlier, an application for substitution was preferred by the appellant being I.A. No. 13518 of 2024, which was allowed on 16.01.2025 allowing the wife of the original Respondent no. 1 to be substituted with a further observation that if it comes to the knowledge of the appellant that there are other surviving heirs of the deceased Respondent No. 1, further steps shall be taken for their substitution. Consequent to the same, the present interlocutory application has been filed.
- 4. In view of the above therefore, the same is allowed and the deceased Respondent who has already been substituted by his wife as his legal heir, shall

also be substituted by his legal heirs, as mentioned in paragraph-6 of the instant application. Office to do the needful.

- Mr. Sanjay Prasad, learned counsel for the wife of the deceased Respondent No. 1 who has also already been substituted, shall take instruction, whether he will also appear on behalf of rest of the substituted legal heirs or not.
- 6. The aforesaid I.A. stands disposed of.
