Heard Mrs. Darshana Poddar Mishra, learned AAG-I for the appellant and Mr. Bhaiya Bishwajeet Kumar, learned counsel appearing for the respondents.

This interlocutory application has been preferred by the appellant for substituting the respondent no. 1 by

his legal heir as it has been stated that the respondent no. 1 has died on 08.06.2022 and is survived by his wife.

However, Mr. Bhaiya Bishwajeet Kumar, learned counsel appearing for the respondent no. 1 submits that he has information that the children of the respondent no. 1 are also the surviving heirs. It has also been submitted by Mr. Bhaiya Bishwajeet Kumar, learned counsel for the respondent no. 1 that he has no contact with the family of the respondent no. 1 and on consideration of the averments made in the instant application the same is allowed and the respondent no. 1 is substituted by his wife as mentioned in para 5 of the instant application.

Let notice be issued to the substituted heir of the respondent no. 1 both under registered cover with A/D as well as under ordinary process, for which, requisite etc. be filed within a period of two weeks.

If on appearance of the wife of the respondent no. 1 as indicated above it comes to the knowledge that there are other surviving heirs of the deceased-respondent no. 1 further steps be taken by the learned counsel for the appellant for getting them substitution.

Let this case be listed on 28th February, 2025 along with the other analogous cases.
