Heard learned counsel for the parties through V.C.

- 2. The instant writ application has been preferred by these petitioners for a direction upon the respondent-HEC for payment of gratuity and leave encashment.
- At the very outset, learned counsel for the petitioner submits that the amount of gratuity as well as leave encashment has been paid to all these petitioners. However, he submits that no interest has been given to them as such the petitioners may be granted liberty to approach the respondent-HEC for grant of interest on the delayed payment of gratuity and leave encashment.
- Learned counsel for the respondent-HEC does not have any serious objection on the aforesaid contention of the learned counsel for the petitioners.
- 5. In view of the aforesaid facts and submission of the learned counsel for the petitioners, the instant writ application is disposed of with a liberty to the petitioners to approach the respondent No.2by filing representation for grant of interest on account of delayed payment within a period of eight weeks from today. If any such representation is filed before the respondent No.2, the same shall be disposed of as early as possible preferably within a period of

four months from today in accordance with law, rules, regulations and policy decision of the respondent organization.

- 6. With the aforesaid directions this writ application is disposed of.
- 7. As I disposed of the main application, the connected application (I.A Nos.4585 of 2017) shall stand disposed of.
