- 2. The present civil revision application has been filed

against the order dated 20.02.2023, passed by the court of learned Civil Judge (Sr. Division) – III, Palamau in Miscellaneous Case No.3 of 2023, whereby the Title Suit No.90 of 2005 has been restored, which was dismissed for default.
