- 2. Taken on record.
- 3. In this batch of Letters Patent Appeals, the State of Jharkhand has challenged the judgement pronounced on 16th February, 2022 passed in W.P. (S) No. 2378 of 2019 and batch matters in W.P. (S) No. 3770 of 2019, W.P. (S) Nos. 2877 of 2019, W.P. (S) Nos. 4541 of 2019, W.P. (S) Nos. 3140 of 2019, W.P. (S) Nos. 2693 of 2019, W.P. (S) Nos. 4553 of 2019, W.P. (S) Nos. 2818 of 2019, W.P. (S) Nos. 2819 of 2019, W.P. (S) Nos. 2917 of 2019, W.P. (S) Nos. 2974 of 2019, W.P. (S) Nos. 4507 of 2019, W.P. (S) Nos. 3168 of 2019, W.P. (S) Nos. 4552 of 2019, W.P. (S) Nos. 2981 of 2019, W.P. (S) Nos. 2870 of 2019, W.P. (S) Nos. 5072 of 2019, W.P. (S) Nos. 3282 of 2019.
- 4. This Court is apprised that a batch of Letters Patent Appeals preferred against the aforementioned judgement delivered by the Writ Court was put to challenge by the State of Jharkhand and by an order dated 15th September, 2023 the Letters Patent Appeals filed by the State of Jharkhand were dismissed by a coordinate Bench of this Court.

- 5. Later, a batch of fourteen Letters Patent Appeals filed by the State of Jharkhand against the very same judgement delivered by the writ Court in W.P. (S) No. 2378 of 2019 and batch cases were dismissed by another coordinate Bench of this Court vide Judgement dated 31st January, 2024 passed in L.P.A. No. 510 of 2023 with analogous cases
- 6. In the aforementioned batch of Letters Patent Appeal, this Court issued the following directions;
 - " (a) Only those candidates are to be called for counseling who have never been called for counseling earlier in one or the other district irrespective of the fact as to whether they had participated in the counseling or not.
 - (b) To enable the candidate to participate in the fresh counseling the concerned respondent shall verify whether a candidate below in the merit list in the concerned district has been ultimately selected irrespective of the fact as to whether such a candidate had joined or not. If that be so, then only such candidate be permitted to appear in the fresh counseling.
 - (c) There should be one counseling to be conducted simultaneously in all the districts as was directed by this Court in W.P. (S) No. 19 of 2016 and other analogous cases which has been upheld in L.P.A. No. 168 of 2017."
- 7. Mr. Ravi Prakash Mishra, the learned State Counsel appraised the Court that the State of Jharkhand has taken a decision to conduct one time counselling for appointment to the post of Para-Teachers.
- 8. Having regard to the Government decision as contained in resolution dated 28th February, 2024, the present Letters Patent Appeals have been rendered as infructuous and disposed of as such.

- 9. The appellants are aggrieved by the Writ Court's decision passed in W.P. (S) No. 3051 of 2019.
- 10. 38 aspirants out of 99 writ petitioners who were party in W.P. (S) No. 3051 of 2019 have come together to challenge the order dated 5th July, 2022 passed in W.P. (S) No. 3051 of 2019.

In view of the decision rendered by this Court in batch of Letters 11. Patent Appeals vide L.P.A. No. 510 of 2023 and analogous cases, the order dated 5th July, 2022 is set aside and the candidates who are the appellants in the present Letters Patent Appeal if eligible and fulfil all other conditions as indicated in the Resolution dated 28th February, 2024, shall be permitted to participate in one time counselling proposed by the State of Jharkhand.
