By the instant writ petition, the order of the Deputy Commissioner, Bandipora, respondent no. 3, bearing no. DCB/VC/2021/PS/895-989 dated 06.07.2021, for short impugned order, in terms whereof the license no. 03 dated 17.4.2018, to import and store petroleum class B, otherwise than bulk in quantity not exceeding 25000 litres at Pushwari Tehsil Hajin, District Bandipora, has been suspended on the ground of non-adherence to the norms prescribed for the import and storage products (MS and HSD) and also for not following the terms and conditions laid down overleaf the license, has been challenged besides the order of the respondent no. 2, Divisional Commissioner, Kashmir, passed in an appeal filed before him against the order of the respondent no. 3, whereby the appeal of the petitioner has been rejected, is also under challenge on the grounds detailed out in the writ petition.

Mr Sofi, learned counsel for the petitioner, while reiterating the grounds taken in the writ petition, submits that there is not only adherence to the procedure but the non-application of mind is also writ large on the impugned orders besides being discriminatory as is evident from the action of the respondents in dealing with the cases of other license holders who were also found as having violated the norms of the license. He has placed on record the notices issued Bilal Ahmad Sheikh, Nissar Ahmad Sheikh, Mushtaq Ahmad Parray etc and submits that no action is taken against these license holders.

In continuation of arguments it has become necessary to call for the records of respondents 2 and 3 through Mr M. A. Chashoo, AAG, who is incidentally available in the court. He shall ensure filing of the response within one week.

Failure of the respondents to submit the record and reply will pave a way for the petitioner to seek interim relief on the next date.

Mr M. A. Chashoo, AAG, is impressed upon to conduct the case himself and shall not handover the brief to any allocated counsel.
