These writ petitions are filed under Articles 226 and 227 of the Constitution of India with a prayer to direct the University viz., Bangalore University as well as Rajiv Gandhi University of Health Sciences to regularise their admission and/or in the alternative to direct the respondents 1, 2 and 5 to transfer the petitioners from the colleges to which they were permitted to join by the CET cell as well as by the management of the colleges and etc.,

These writ petitions coming on for preliminary hearing this day the court made the following:

The petitioners in all these writ

2. In these writ petitions, the common relief that the petitioners are seeking is for a direction to the University, viz., Bangalore University as well as Rajiv Gandhi Health University of Sciences to regularise their admission and/or in the alternative to direct the respondents 1, 2 and 5 to transfer the petitioners from the colleges to which they were permitted to join by the CET cell as well as by the management of the colleges.

When

When the allotments were made by the CET cell during the academic years 1993-94, 1994-95, 1995-96 and 1996-97, some of the colleges to which the petitioners were allotted were not recognised by the Dental Council of India and the Central Government. Similar is the situation in respect of the students who have been admitted under the management quota. Therefore, all these petitioners have now approached this court with the reliefs sought for in these writ petitions which has been briefly stated supra.

3. Under similar circumstances, this court in WP Nos.38737-753/1999 and other connected writ petitions, disposed of on 19.11.1999 has issued certain directions to the University/Universities. This court after considering the various contentions urged by the parties in those writ petitions has

## issued the following direction: -

"I however consider it more appropriate to direct that the Registrar of the Bangalore University shall verify the information which the colleges may furnish to him in regard to the vacancies in the second, third and 4th year of the BDS Course. If upon verification, vacancies are found to be existing, transfer of the petitioners against the same shall be permitted taking into consideration the choice of the candidate concerned and his merit at the time of his admission to the 1st year of the course. The transfer shall be against vacancies in the categories in which the petitioners were initially admitted. In case however, any one of the petitioners wishes to be transferred again to a management seat, the Registrar shall permit such a transfer subject to the candidate agreeing to pay the preseribed tuition fee and other charges applicable for such seats. Keeping in view the urgency involved in the

matter, the entire exercise of verification of seats and transfer of the petitioners against the same shall be expedited to be completed within three weeks from today. The transferee colleges mentioned earlier shall furnish to the Registrar of the Bangalore University, the requisite information regarding the availability of the vacancies within one week. They shall also furnish any other information which the Registrar may require in that connection. In case the vacancies in the colleges aforementioned are insufficient to accommodate all the petitioners, the Registrar shall be at liberty to call for the requisite information from other recognised colleges in the State and make allotment against the same. The transfers permitted after verification of the vacancy position shall be recognised by all concern including the Rajiv Gandhi University of Health Sciences wherever the transferred students have to appear in examinations organised by the said University. shall

4. These writ petitions are disposed of in terms of the above directions of this court. The petitioners shall appear before the Registrar of the Bangalore University on 10th February 2000 at 10.30 a.m. in his Office or on such other date as the Registrar may fix on the date as the Registrar may fix on the petitioners. But the entire process of the allotment shall be completed by the Registrar of the Bangalore University on or before 17th February 2000. The appearance of the petitioners for the ensuing examination will be subject to their academic eligibility to be determined

by the concerned Universities.

5. All these writ petitions are accordingly disposed of with the above direction leaving the parties to bear their own costs.
