THIS APPEAL IS FILED UNDER SECTION 173(1) OF MV ACT AGAINST THE JUDGMENT AND AWARD DATED 19.06.2019 PASSED IN MVC NO.2098 OF 2017 ON THE FILE OF THE II ADDITIONAL DISTRICT AND SESSIONS JUDGE AND ADDITIONAL MACT, HASSAN, PARTLY ALLOWING THE CLAIM PETITION FOR COMPENSATION AND SEEKING ENHANCEMENT OF COMPENSATION.

THIS APPEAL COMING ON FOR CONCILIATION BEFORE LOK ADALAT, THE FOLLOWING CONCILIATION ORDER IS PASSED.

### **CONCILIATION ORDER**

1. This Miscellaneous First Appeal is filed against the Judgment and Award passed by the above Tribunal having been referred to Lok Adalath by the Court coming on for settlement before Lok Adalat on 25.06.2022 in the presence of the Officers of the **Reliance Gen. Ins. Co. Ltd.** and advocates appearing for the respective parties, for the reasons stated in the Conciliation Order.
2. The learned Counsel appearing for the Appellant - claimant and the learned Counsel appearing for the second Respondent - **Reliance Gen. Ins. Co. Ltd.** along with its representative are present.
3. After prolonged negotiations, the matter is settled. A joint memo signed by the learned advocate appearing for the appellant (being authorized by the appellant to sign) and

the learned advocate appearing for the second Respondent - Insurance Company and its authorized officer is filed, which reads as under:

*"The MFA filed against the Judgment and Award in **MVC No.2098/2017** on the File of the **MACT, Hassan** has been referred to this Lok Adalat by the Hon'ble High Court U/S.20 of the Legal Services Authorities Act, 1987. The parties to the appeal have settled their claim before the Lok Adalat on the following terms:*

*The Appellant has agreed to receive and Respondent **RELIANCE GEN. INS. CO.**, has agreed to pay a lump-sum of Rs.1,20,000/- (Rupees One Lakh Twenty Thousand only) in addition to what has been awarded by the Tribunal, in full and final settlement of the claim.*

*The Respondent **RELIANCE GEN. INS. CO.**, has agreed to deposit the said amount, before the Tribunal, within six weeks from the date of preparation of award failing which the said amount shall carry interest at 9% p.a. from the date of default, till the date of deposit. The parties are not entitled for any cost.*

*The parties to this appeal have set their hands to this settlement before the Lok Adalat in the presence of Conciliators on this 25.06.2022 at Bengaluru Bench".*

4. The appellant – claimant has agreed to receive and the second Respondent - Insurance Company has agreed to pay a lump-sum of Rs.1,20,000/- (Rupees One Lakh Twenty Thousand only), in addition to what has been awarded by the Tribunal, in full and final settlement of the claim.
5. The second Respondent - Insurance Company has agreed to deposit the said amount before the Tribunal within six

weeks from the date of preparation of award, failing which, the said amount shall carry interest at the rate of 9% P.A. from the date of default, till the date of deposit.

6. The entire enhanced compensation amount shall be released in favour of the appellant – claimant, on proper identification.
7. This Miscellaneous First Appeal stands disposed of in terms of the Joint memo. The Judgment and Award of the Tribunal shall stand modified accordingly. Draw up the Award accordingly.
