ORDER

The marriage between the petitioner and the respondent was performed on 6.5.2005. The respondent-wife files a petition seeking dissolution of the marriage on the ground of cruelty.

- 2. During the pendency of the proceedings, the respondent files an application seeking interim maintenance of ₹.20,000/-. The said maintenance is for herself and for the child.
- 3. The learned Family Judge having regard to the avocation of the petitioner and also the probable income which he would earn awarded a sum of ₹.5,000/- p.m. as against, which the husband is before this Court.
- 4. I have heard the learned counsel appearing for the petitioner.
 - 5. I have perused the impugned order.
- 6. Apparently, the petitioner owns an autorickshaw and is earning substantially. The petitioner's family owns two sites that apart the
