THIS CIVIL MISC. THIS PETITION, COMING ON FOR ADMISSION, THIS DAY, THE COURT MADE THE FOLLOWING:

### **ORDER**

The learned counsels for the parties submit that existence of a dispute as also the agreement for resolution of dispute by arbitration are not disputed. In fact, the learned counsels submit that the parties have agreed for resolution of dispute by a panel of

three arbitrators but given the nature of the dispute, a sole arbitrator could be appointed leaving open all the questions to be decided in the arbitral proceedings.

In the light of the unanimous submission, the petition is allowed appointing Shri.J.S. Somashekara, a retired District Judge, as the sole arbitrator to enter reference of the dispute between the petitioner and respondent and conduct the proceeding at the Arbitration and Conciliation Centre (Domestic and International), Bengaluru according to the Rules governing the Arbitration and Conciliation Centre (Domestic and International), Bengaluru.
