This Writ Petition is filed under Articles 226 and 227 of the Constitution of India, praying to direct R 1 to accept the cause already shown to the show cause notice vide Annexure-C dated 31 10 1977 revoke the suspension of pension sanctioned on 14 12 1974 and restore the pension sanctioned to the petitioner and pay the amount of pension withheld from 1 11 1977 together with the revision effected on and from 1 8 1980 and 1 6 1985 together with interest at the rate of 6% P A till the date of payment, for the inordinate delay caused in the matter of holding enquiry for the past twenty-five years

The petitioner in this Writ Petition has sought for quashing of Annexure-C under which, the pension granted to the him was suspended and for restoration of pension sanctioned to him

2 This Court by an interim order dated 22 10 2002 has directed the respondents to consider and pass appropriate order by

considering the documents already submitted by the petitioner for grant of pension on 26 2 2003 since the respondents have not furnished the information regarding compliance of the interim order, I passed an order directing the office to issue a show-cause-notice as to why contempt proceedings shall not be initiated

- 3 Now the counsel for the respondents have filed an affidavit along with an order passed by the respondents on 31st January, 2003 Accepting the cause shown in the affidavit, I order to drop any further proceedings under the Contempt of Courts Act
- 4 Since the respondents have passed the order granting pension in favour of the petitioner, this Writ Petition does not survive for consideration. If at all the petitioner is aggrieved of the order at Annexure-R-I which is produced along with the affidavit, it is open for the petitioner to challenge the same
