THIS WRIT PETITION IS FILED U/A 226 & 227 OF CONSTITUTION OF INDIA WITH A PRAYER TO SET-ASIDE THE ENDORSEMENT ISSUED BY THE 1<sup>ST</sup> RESPONDENT DATED 27.11.2009 VIDE ANNEXURE-O AND ETC.

This petition coming on for preliminary hearing, this day, the court made the following;



#### ORDER

- 1. In this writ petition the petitioner has prayed for a writ in the nature of certiorari to quash the endorsement dated 27.11.2009, Annexure-O.
- 2. Petitioner contends that his correct date of birth is 8.6.1956 as per the SSLC marks card. But by mistake at the time of initial entry into the service of respondents, the date of birth of petitioner was mentioned as 8.6.1952. Therefore, the petitioner made a request to the respondents to enter the correct date of birth as 8.6.1956 in his service records. Under the impugned endorsement, the respondents have rejected the claim of petitioner. Hence, this writ petition.
- 3. Admittedly, the petitioner joined the service of respondent in the year 1975. Within a reasonable time of one year, the petitioner had not requested the respondents to correct the date of birth in his service records. At the fag end of his service, the petitioner

requested the respondents to correct his date of birth in the service record. In the circumstances, the respondents have rightly rejected the request of the petitioner under the impugned endorsement, Annexure-O. I find no justifiable ground to interfere with the same. Accordingly the writ petition is hereby rejected without reference to respondents.
