ORDER

3. In these representations, the petitioners contend that they are working for the last 05 to 20 years in the 4th respondent Educational Institution as non-teaching staff. In these representations, the petitioners have prayed for job security and not to remove them from service.

4. No prejudice will be caused to the respondent if they are directed to consider the



petitioners representations (Annexures - Y and Z) in accordance with law.
