This Miscellaneous First Appeal is filed under Section 173(1) of Motor Vehicles Act against the Judgment and Award 18.01.2001 in MVC.NO.1287/1998 on the file of the Prl.Civil Judge (Sr.Dn.) & Member, Addl. MACT, Belgaum, partly allowing the claim petition for compensation and seeking enhancement of compensation.

This Miscellaneous First Appeal coming on for Conciliation before the Lok Adalath, K.SREDHAR RAO, J., passed the following:

CONCILIATION ORDER

Appellant's Counsel present. Representative of Respondent No.2 and its Counsel present.

2. On re-working of the compensation, the claimant would be entitled to an additional lumpsum compensation of Rs.1,17,000/- (Rupees One Lakh Seventeen Thousand only) in addition to what has been awarded by the Tribunal, in full and final settlement of the claim. The Insurance Company is agreeable for the proposal. The claimant is also agreeable. Joint Memo is filed on behalf of the parties to this effect.

3. The Respondent No.2 has agreed to deposit the said amount before the Tribunal within six weeks from the date of preparation of Award, failing which the said amount shall carry

interest at the rate of 8% P.A. from this date till the date of payment.

4. The entire amount to be paid to the claimant.

5. This Miscellaneous First Appeal stand disposed of in terms of the Joint Memo. The Award of the Tribunal stands modified accordingly.

Draw up the Award accordingly.
