On the basis of a complaint lodged by the 2<sup>nd</sup> respondent, first respondent having registered case in Crime No.76/2013 and upon conducting of investigation, having submitted the final report, cognizance was taken and C.C.No.352/2014 was registered. Process having been issued, the petitioner/accused No.2 filed this petition seeking quashing of the entire proceedings pending before the Additional Chief Judicial Magistrate, Bengaluru Rural District, Bengaluru.
