ORDER

Mr. Santhosh S. Gogi, learned counsel for the complainant.

Mr. R.L.N. Murthy, learned counsel for the accused.

This petition has been filed alleging non-compliance of the direction contained in the order dated 23.3.2021 passed by the learned single Judge in W.P.No.337/2021.

- 2. When the matter was taken up today, the learned counsel for the respondent submits that in compliance of the aforesaid direction, single layout plan has been sanctioned by the respondent on 1.10.2021 subject to the result of the review petition which is pending.
- 3. In view of the aforesaid submission, the learned counsel for the complainant submitted that since the layout plan has been approved subject to result of the review petition which is pending, the Hindustan Petroleum Corporation Limited shall not give any allotment to the complainant.

- 4. Be that as it may, in this contempt proceedings, the direction issued by this Court has been complied.
