Though this petition is listed for orders, with the consent of the learned Counsel for the parties, is finally heard and disposed of by this order.

2. Facts admitted are that the petitioners, engaged temporarily as Meter Readers on consolidated salary, are not selected in a regular recruitment under the Cadre & Recruitment Regulations of the respondent, Mangalore Electricity Supply Company Ltd., and the

Karnataka Power Transmission Corporation Ltd., against sanctioned vacant posts, duly qualified. If that is so, petitioners have no legal right to claim regularisation / absorption / permanency in the said post. In the light of the decision of the constitution Bench of the Apex Court in SECRETARY, STATE OF KARNATAKA & OTHERS VS. UMADEVI (3) & OTHERS, reported in (2006) 4 SCC 1, the claim of the petitioners for regularisation is unsustainable.

Petition is accordingly rejected.

Miscellaneous application is rejected as unnecessary.
