ORDER

H.G.RAMESH, J. (Oral):

In these writ petitions, the petitioners are challenging the order dated 29.01.2015 (Annexure-A) wherein the

State Government has resolved to make good the *difference of share* price to be payable by members of Co-operative Societies belonging to Scheduled Castes and Scheduled Tribes. In my opinion, the order does not contravene any of the provisions of the Constitution to warrant interference under the extraordinary jurisdiction of this Court under Articles 226 and 227 of the Constitution. The writ petitions are devoid of merit.

Petitions dismissed.
