ORAL JUDGMENT

It is submitted by the learned counsel appearing on either side that the disputes between the parties which has given rise to this Commercial Appeal has been settled in mediation between them. It is contended that the settlement entered into between the parties produced in writing in the form of Memorandum of Settlement. It is stated that the appellant has agreed to pay a sum of

Rs.34,00,000/- (Rupees Thirty four lakhs only) towards full and final settlement of all the claims of respondent. It is submitted that the amount of Rs.20,00,000/- (Rupees Twenty lakhs only) has been deposited before the Commercial Court in Execution Petition No.418/2022 and further amount of Rs.5,00,000/- (Rupees Five lakhs only) has been deposited before this Court in this Commercial Appeal.

- 2. It is submitted that further, a demand draft dated 25.06.2024 bearing No.504919 for an amount of Rs.9,00,000/- (Rupees Nine lakhs only) is being handed over today by the appellant to the respondent in Court. It is further submitted that the Court Fee of Rs.1,96,998/-(Rupees One lakh ninety six thousand nine hundred and ninety eight only) paid by the appellant before this Court shall also be paid to the respondent and the Commercial Appeal shall be withdrawn recording the settlement.
- 3. The parties as well as the learned counsel are present in Court today and they submit that the entire

disputes have now been settled in terms of settlement arrived at in mediation. It is submitted that terms of settlement are agreed upon between the parties. It is further submitted that the appellant has no objection to the Court fees paid in respect of this appeal being paid to the respondent in terms of the agreement arrived at between the parties.

- 4. In the above view of the matter, the Commercial Appeal is ordered in terms of the Memorandum of Settlement arrived at between the parties in mediation. The said Memorandum of Settlement shall form part of the judgment in this Commercial Appeal which shall stand settled and withdrawn in terms of the same.
- 5. The payment of the amounts which are deposited by appellants as well as the Court Fee paid shall be released in favour of respondent in terms of agreement arrived at between the parties. It is further agreed between the parties that the entire claim of the

respondent has been settled by the appellant in terms of the agreement arrived at between the parties.

- The Commercial Court as well as the Registry of 6. this Court shall release the amounts as agreed herein to the respondent on proper identification.
- Accordingly, the Commercial Appeal stands 7. disposed of.
