In this petition filed by the petitioner-wife against respondent-husband, the petitioner seeks transfer of M.C.No.1782/2021 pending before the Principal Judge, Family Court, Bengaluru to the Principal Family Court, Davanagere, where the petitioner- wife is residing.

2. A perusal of the petition in M.C.No.1782/2021 filed by the respondent-husband herein indicates that the petitioner-wife is residing at Davanagere. Under this circumstance and in view of law laid down by the Apex Court in the case of **SUMITA SINGH VS. KUMAR** SANJAY AND ANOTHER reported in AIR 2002 SC 396, it is observed that the convenience of the wife has to be looked into at the time of considering the transfer application filed under Section 24 of the Code of Civil Procedure, which is further followed by a co-ordinate Bench of this Court SUHASINI the case of S.B.MAHENDRA KUMAR reported in ILR 2015 KAR **2804**, the petition deserves to be allowed.

3. Accordingly, the petition is **allowed** and M.C.No.1782/2021 pending on the file of the Principal Judge, Family Court, Bengaluru is hereby transferred to the Principal Family Court, Davanagere for disposal in accordance with law.

However, liberty is reserved in favour of the respondent to seek necessary exemption from personal appearance, whenever possible before the Court at Davanagere to which the aforesaid M.C.No.1782/2021 now stands transferred to. Respondent is also reserved liberty to request the Court for the proceedings to be conducted through video conferencing.
