O R D E R

Respondent No.2 having lodged a complaint before respondent No.1 on 29.04.2015, case in Crime No.72/2015 was registered and FIR was submitted to the Addl. Civil Judge and JMFC at Doddaballapur. Petitioner having been named as an accused in the said case, alleging commission of offence under S.365 of IPC, this petition was filed to quash the said proceedings.

2. Heard Sri S.A. Khadri, learned advocate for the petitioner and Sri B. Visweswaraiah, learned HCGP for the 1st respondent.

3. In the aforesaid complaint, the 2nd respondent / informant has identified the petitioner as one of the persons who kidnapped her husband after vandalizing the premises wherein they are residing. Husband of the petitioner - Sri Ramprasad, has given a statement before

the I.O. with regard to incident in question and the petitioner along with others having assaulted and kidnapped him. Whether the alleged incident is true or otherwise is a matter of investigation.

In the circumstances, there is no justification to entertain this petition.

Petition is rejected.
