THIS PETITION, COMING ON FOR PRELIMINARY HEARING IN 'B' GROUP, THIS DAY, THE COURT MADE THE FOLLOWING:

ORDER

A memo dated 08.12.2023 is filed by learned counsel appearing for the respondent Nos.6 to 9.

2. In the present writ petition, as the main relief is as against the order dated 15.04.2023 passed by respondent No.2 rejecting the application for impleading and as it is now submitted that the appeal proceedings

have culminated in the final order, the relief sought for does not survive for consideration.

- 3. Accordingly, the petition is dismissed as having become infructuous. However, all legal contentions between the parties remain unadjudicated and are kept open.
- 4. Learned counsel Sri. K.S.Mallikarjun Reddy appearing for respondent BBMP submits that after the appeal filed before the Karnataka Appellate Tribunal reaches the finality, consequential action would be taken according to law without much delay.

Recording the said submission, the petition is **disposed off**.
