Petitioner is grieving against the long pendency of his CMP/180110/0000394 which was filed on 07.08.2019. Learned counsel for the petitioner argues that statutorily speaking, such a complaint should be disposed off within a period of sixty days and therefore, a direction be issued in that regard.
