ORDER

Heard Sri.A.G.Nagaraja, learned advocate for the petitioner and perused the petition.

- 2. Learned advocate, to a pointed question of the Court, conceded that the issues in OS Nos.376/2011 and 139/2010 being distinct and separate, there is no need for a common trial i.e., by clubbing of the cases.
- 3. When there is no need for holding of a common trial, it is unnecessary to permit the transfer of the suits to one and the same Court.
- 4. Thus, petition filed under Section 24 of CPC, to transfer OS No.376/2011 pending on the file of the Principal Civil Judge, Malur to the Court of First Additional Civil Judge, Malur wherein OS No.139/2010 is pending, is being devoid of merit, learned District Judge is justified in dismissing the Misc. petition.
