ORDER

This petition is filed seeking a writ of mandamus directing respondent No.1 - Regional Transport Authority, to consider the applications for renewal at Annexures-A, B,

- 2. The learned counsel for Respondent no.1 authority contends that if adequate time is granted, the applications would be considered. In view of the submission made, the petition is allowed.
- 3. Respondent Authority is directed to consider the renewal applications at Annexures-A, B, C and D-1 TO D-27, in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order.
- 4. Learned Government Advocate is granted four weeks time to file his memo of appearance.
