ORDER

In the instant petitions petitioners have prayed for the following reliefs:

(i) *Issue a writ or order in the nature of writ of mandamus directing Respondents to accept the 10th Standard Marks Card produced by the Petitioner as contained under Annexure-C, regarding selection of Petitioner to the post of Driver and;*

(ii) *Pass such other orders as the petitioner is entitled to in the facts and circumstances of the case, including the costs of the proceedings in the interest of justice and equity.*

2. During pendency of the present petitions, respondents were stated to have examined the grievance of the petitioners and found that they were not selected to the post of drivers.

In view of the aforesaid position, petitions do not survive for consideration. Accordingly, writ petitions stand dismissed as having become infructuous.
