Civil Judge (Sr.Divn.) and JMFC, Anekal in

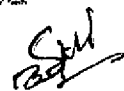
O.S. No.123/2006 and by allowing the above appeal.

J U D G M E N T

The subject matter of this appeal is valued at less than Rs.10.00 lakhs. The appeal is filed after coming into force of the Karnataka High Court and Certain other Laws (Amendment) Act, 2007 on 26.06.2007. By virtue of the said Act, if the valuation of the appeal is less than Rs.10,00,000/-, the jurisdiction is conferred on the District Court. Hence, the appeal is not maintainable before this Court.
