ORDER

The complainant has filed the present contempt petition against the accused to take action under the provisions of Sections 11 and 12 of the Contempt of Court Act for wilful disobedience of the order dated 09.12.2020 made in W.P. No.11819/2018, wherein the learned Single Judge while disposing the petition, directed the respondent-KPTCL to consider the case of the complainant for appointment to the post of "Junior Assistant" in place of third respondent therein.

2. Smt. Rakshitha D.J., learned counsel for the accused fairly submits that though a writ appeal came to be filed against the order of the learned Single Judge in W.A. No.769/2021, same was dismissed on 14.09.2021. Thereafter the order of the learned Single Judge has been complied by issuing the appointment order as per Annexure-R2. The said submission is placed on record.

3. Shri Somashekar Kashimath, learned counsel for the complainant has filed a memo dated 18.01.2022,

fairly submits that the order of the learned Single Judge has been complied.
