THIS W.P. COMING ON FOR PRELIMINARY HEARING THIS DAY, THE COURT MADE THE FOLLOWING:

## ORDER

Smt.Prathima Honnapura, the learned Government Pleader takes notice for the respondent Nos.1 to 3. The issuance of notice to the respondent No.4 is dispensed with.

- 2. The petitioner has made the following prayers:-
- "a) Issue writ of certiorari or any other direction directing R4 to stop the unilateral and arbitrary process of promotion under taken by the respondent No.4 without considering the name of the petitioner who is otherwise entitled under law:
- b) To direct the respondent No.4 to consider the name of the petitioner to the post of the principal in the respondent No.4 college in accordance with law.
- c) To direct the respondent No.1 to 3 initiate action against the respondent No.4 if the process of promotion to the principal is already through in the latter college contrary to law;
- d) Pass any other/direction as this Hon'ble Court deems in this case including the cost on the respondent No.4 in the interest of justice and equity."

- 2. I am afraid none of these prayers are grantable in the proceedings under Article 226 of the Constitution of India.
- 3. Keeping all the contentions open and reserving the liberty to the petitioner to avail of the remedy of filing the petition for directions under Section 133(2) of the Karnataka Education Act, 1983, I dispose of this petition.
- 4. If the petitioner files one such petition within seven days from today, the concerned Authority shall dispose it of as expeditiously as possible and in any case within six weeks from the date of its filing. It is also open to the petitioner to seek appropriate interim orders in the anticipated petition for direction. If the petitioner files I.A. for stay, etc. in the anticipated petition, the same shall be disposed of within ten days of its filing.
  - 5. No order as to costs.
