CONCILIATION ORDER

This Writ petition is filed challenging the Order dated 12.09.2012 and Award dated 18.11.2013 in Ref.No.3/2011 passed by the Presiding Officer, Labour Court, Mysuru vide Annexure-'H' and 'K' respectively.

2. After negotiations, the parties have arrived at settlement. According to the settlement, that the respondent-workman to be reinstated into service with continuity of service and consequential benefits excluding the period from the date of dismissal on 04.01.2005 till the date of petition for conciliation is filed. Further, it is agreed that the respondent-

workman will not be entitled for any other benefits from the date of dismissal till the date of actual reinstatement pursuant to the Interim Order dated 27.03.2015. A Joint Memo is filed on behalf of the parties to this effect.

3. Accordingly, this Writ petition filed by the Corporation is disposed of modifying the Order dated 12.09.2012 and Award dated 18.11.2013 in Ref.No.3/2011 passed by the Presiding Officer, Labour Court, Mysuru vide Annexure-‘H’ and ‘K’ respectively.
