THIS WRIT PETITION IS FILED UNDER ARTICLES 226 AND 227 OF THE CONSTITUTION OF INDIA PRAYING TO QUASH THE AWARD DT.19.12.2006, PASSED BY THE LABOUR COURT, BANGALORE IN I.D.NO.57/1996 PRODUCED AS ANN-T AND ETC.,.

THIS WRIT PETITION COMING ON FOR HEARING THIS DAY, THE COURT MADE THE FOLLOWING:

ORDER

Both the learned Senior Counsel for the parties submit that the matter has been amicably settled between the parties and they seek time to file Joint Memo to that effect. Sri Poonacha, the Secretary of the Union of Petitioner-workman is present before the Court. The learned Senior Counsel also submit that since the matter has been amicably settled between the parties, the same be disposed of.

2. The terms of the joint memo would be that Management has agreed to pay globally Rs.7,00,000/- to each of the workmen who have taken wages under Section 17-B of the Industrial Disputes Act; and Rs.50,000/- more to the persons

who have not got 17-B wages. The submission is placed on record and the parties are permitted to file a joint memo to that effect in the office, within a period of eight weeks. This payment includes settlement of all the dues, including statutory and non-statutory. The amount is to be disbursed to the individuals by way of cheque/Demand Draft in two instalments. It is also made clear that the wages paid is spread-over for the period of unemployment.

Petition accordingly stands disposed of.
