TO RELEASE THE SON OF THE PETITIONER SOMU D N CTP 14285 ON GENERAL PAROLE FOR A PERIOD OF 90 DAYS IN THE INTEREST OF JUSTICE.

**THIS** PETITION, COMING ON FOR **PRELIMINARY** HEARING, THIS DAY, ORDER WAS MADE THEREIN AS UNDER:

#### **ORAL ORDER**

The petitioner's son, Somu D.N. (CTP No. 14285), has been convicted for offences punishable under Sections 302 and 506 of the Indian Penal Code (IPC) and sentenced to undergo life imprisonment.

- The petitioner seeks a directive to the respondents to release her son on parole, citing that she is suffering from acute gastroenteritis and has been advised 15 days of bed rest along with further treatment. This is supported by a certificate issued by the Health and Family Welfare Department, Bookanakere, K.R. Pete Taluk, Mandya District.
- 3. It is submitted that the convict has served more than four years of his sentence as of today and has not been released on parole previously.
- 4. In light of these circumstances, the petitioner has established a prima facie case for the release of her son on parole. Accordingly, I pass the following;

### **ORDER**

- The Writ Petition is allowed. a.
- b. Respondent No.2 is hereby directed to release the son of the petitioner/convict viz., Somu D.N., CTP No.14285 on parole for a period of 90 days from the date of his release, subject to prisoner undertaking not to involve in unlawful activities during the parole.
- C. Respondents shall stipulate strict conditions as are usually stipulated to ensure their return to the prison and the convict shall not commit any other offence during the period of parole.
- d. The Registry is directed to communicate this order to respondents, by way of electronic mail to the jail authorities, forthwith.
- The brother of the petitioner-convict is at e. liberty to seek extension of parole.
