## **ORAL ORDER**

The petitioner's grievances is that although the petitioner-is arrayed as defendant No.13 in O.S.No.3932/2017, the defendant Nos.1 and 2 filed a petition under Section 24 of CPC, and sought for dispensation of service of notice to the petitioner. Thereafter, the Trial Court without hearing the petitioner has posted the matter for judgment.
