## ORDER

These are writ petitions, captioned as public interest litigation, seeking, *inter alia*, the removal of manual scavenging from the city of Bengaluru.

- 2. We have heard the learned advocates appearing for the parties.
- 3. Learned senior counsel appearing for Bengaluru Water Supply and Sewerage Board submits, on instructions, that steps have, already, been initiated for eradicating manual scavenging totally. He submits that in majority of the areas, manual scavenging has been eradicated and machines have been introduced.
- 4. However, there are some areas in the rural Bengaluru district where underground drainage system is not yet introduced. He submits that the cabinet has approved, on principle, a scheme for construction of underground sewage system and the matter has been referred to the Central government for allotment of funds. He submits that as and when the sanction comes, underground sewage system shall be undertaken.
- 5. We dispose of these writ petitions by directing the authorities concerned to expedite the matter for eradication of manual scavenging in terms of the directions passed by the Supreme Court of India in the case of SAFAI KARAMCHARI ANDOLAN AND OTHERS versus UNION OF INDIA AND OTHERS reported in 2014(3) Kar.L.J. 529.

- 6. In view of the disposal of the writ petitions, the interlocutory applications in Writ Petition No.30221 of 2009 become infructuous and those are, also, disposed of.
  - 7. We make no order as to costs.
