THIS WRIT PETITION, COMING ON FOR ORDERS, THIS DAY, THE COURT MADE THE FOLLOWING:

ORDER

- The petitioners are before this Court seeking for the following reliefs:
 - a. Issue writ in the nature of Certiorari and quash the impugned endorsements dated 22.9.2023 bearing Ref No.0547/G. Adinarayan/NPL, 0547/G Varalakshmi/NPL, 0547/G Adinarayan/NPL 0547/K Ashok/NPL, 0547/G Jayesh/NPL, 0547/G Nagamani/NPL vide Annexure-C series.
 - b. Issue writ in the nature of mandamus directing the respondent bank to consider the representation at Annexure-C series and provide OTS scheme to the petitioners.

- C. Issue any other writ or direction as deem fit by the this Hon'ble Court in the interest of justice and equity.
- Sri.SharadV.Magadum., learned counsel for the petitioner submits that he would not press prayer No.1 above and would only seek for orders in respect of prayer No.2.
- 3. Prayer No.2 relates to a representation submitted by the petitioner for consideration of a one-time settlement on 9.1.2023.
- The said OTS proposal has neither been accepted nor rejected by the respondent-Bank. In that view of the matter, I pass the following;

ORDER

- i. The writ petition is *allowed*.
- ii. A mandamus is issued directing respondents to consider the representation of the petitioner, dated 9.1.2023 at Annexure-C within a period of 30 days or the date of receipt of the copy of

this order either accepting or rejecting the proposal.

iii. If the proposal is rejected, it will necessarily have to be followed by reasons considering that the proposal was given one year ago. The petitioner is also permitted to furnish a fresh proposal within one week from today.
