Learned counsel for the petitioner would submits that earlier sanction was accorded under Section 197 of the Criminal Procedure Code (hereinafter referred to as the "Cr.P.C.", for brevity) to prosecute the petitioner in respect of Crime No.68/2020 of Ron Police Station by order dated 12.01.2023.
