ORDER

This petition is filed calling in question the ineligible voters list published for the election to the Board of Directors of the respondent No.2, which was scheduled to be held on 17.02.2024. This Court vide order dated 13.02.2024 permitted the petitioners to vote in the election to be held on 17.02.2024, however, directed the Returning Officer not to announce the results of the election. In light of the interim order granted by this Court, the petitioners have casted their votes in the election, which was held on 17.02.2024. In circumstances, the coordinate Bench of this Court in W.P. No.8502/2022 a/w W.P. No.8477/2022 disposed off on 07.06.2022 called upon the Returning Officer to announce the result forthwith including the votes cast by the petitioners therein. Therefore, this petition also requires to be disposed off in light of the order passed by this Court in WP No.8502/2022 and connected matter to maintain parity. Accordingly, I pass the following:

ORDER

i) The petition is allowed.
