## ORDER

Heard.

- 2. As per investigation records, first petitioner being the Assistant Executive Engineer working in the office of Superintendent Engineer, KPTCL at Munirabad and second petitioner being the Assistant Engineer working at Major Works Sub-Division, KPTCL, Hospet, had not taken care to shift 11 KV line which was drawn over the school building.
- 3. The construction of additional room was taken up by the school authorities. The petitioner came in contact with 11 KV line, which was drawn over the school building and suffered injuries.
- 4. The investigation records would prima-facie establish that petitioners were negligent in discharging their

duties. In the circumstances, there are no grounds to quash the final report in C.C.No.46/2010.

5. Therefore, the petition is dismissed. However, it is made clear that, the trial court while deciding the case on merits shall not be influenced by the observations made in this order.
