It is pending on the file of the Civil Judge and JMFC, Raibag. The respondent has filed M.C. No.323/2013 for restitution of conjugal rights at Belgaum. It is difficult for the 1st petitioner to travel to Belgaum every time to attend the case. Therefore, M.C. No.323/2013 may be transferred to the Court of Senior Civil Judge at Raibag.
