THIS MFA IS FILED UNDER SECTION 173(1) OF THE MOTOR VEHICLE ACT, AGAINST THE JUDGMENT AND AWARD DATED 18.12.2009 IN MFC.NO.2744/2005 PASSED BY THE FAST TRACK COURT-II & ADDL.MACT, BELGAUM, AND ETC.

THIS APPEAL COMING ON FOR CONCILIATION BEFORE THE LOK ADALAT, AFTER BEING REFERRED VIDE ORDER DATED 31.01.2015, THE FOLLOWING ORDER IS PASSED:-

### **CONCILIATION ORDER**

Both sides are present.

2. The 2<sup>nd</sup> respondent-Insurance Company submits that, it is agreeable to pay Rs.1,00,000/- (Rupees One Lakh Only) in lumpsum, i.e., over and above the amount awarded by the MACT, being the full and final settlement of the claim of the appellant.

3. After negotiation, the parties have arrived at a settlement. A joint memo is filed in this regard.

4. Both the parties have signed the consent memo. Thus, the matter having been settled, the 2<sup>nd</sup> respondent-Insurance Company shall deposit the agreed amount before the MACT, within a period of four months from the date of receipt of copy of this order. In case of default, the said amount shall carry interest at the rate of 9% p.a. i.e., after the expiry of four months period.

5. Upon deposit, 50% of the amount is ordered to be deposited in FD in the name of the claimant in any nationalized bank for a period of three years, with a provision for withdrawal of the periodical interest accrued thereon.

6. The remaining 50% of the amount is ordered to be released in favour of the claimant.
