THIS MFA IS FILED U/S 173(1) OF MV ACT, AGAINST THE JUDGMENT AND AWARD DATED 28.08.2014 PASSED IN MVC NO.184/2013 ON THE FILE OF THE SENIOR CIVIL JUDGE AND MEMBER MOTOR ACCIDENT CLAIMS TRIBUNAL, AT GANGAVATHI, PARTLY ALLOWING THE CLAIM PETITION FOR COMPENSATION AND SEEKING ENHANCEMENT OF COMPENSATION.

THIS MFA COMING ON FOR CONCILIATION BEFORE LOK ADALAT AFTER BEING REFERRED VIDE ORDER DATED 22.11.2017 THE FOLLOWING ORDER IS PASSED:

The learned counsel appearing for the appellant and learned counsel appearing for the 3rd respondent-insurance company along with its representatives are present.

- 2. After prolonged negotiations, the matter is settled. The appellant/claimant has agreed to receive and the 3rd respondent-insurance company has agreed to pay a global compensation of Rs.1,65,000/- [Rupees One Lakh Sixty Five Thousand only] in addition to what has been awarded by the Tribunal, in full and final settlement of the claim. A Joint Memo is filed on behalf of the parties to this effect.
- 3. The 3rd respondent-insurance company has agreed to deposit the said amount before the Tribunal within six weeks from the date of preparation of award, failing which the said amount shall carry interest at 9% p.a. from the date of default, till the date of deposit. The parties are not entitled to any cost.
- 4. On deposit of the amount, 50% is agreed to be invested in Fixed Deposit in the name of the appellant/claimant in any Nationalised Bank for a period of three years. The remaining

50% of the amount is ordered to be released in favour of the appellant/claimant.

5. Accordingly, Miscellaneous First Appeal stands disposed off in terms of the Joint Memo. The award of the Tribunal shall stands modified.
