#### **ORDER**

The captioned petition is filed assailing the order passed by respondent No.2 as per Annexure-E and order passed by respondent No.3 as per Annexure-B. The petitioner has knocked the doors of this court on the premises that the petitioner is left remediless, as there is no sitting at Belagavi.

However, the learned standing counsel appearing for respondent No.1 on instruction submits that since there is no appointment to the post of Information Commissioner, petitioner has a remedy to seek transfer of his appeal pending before the Belagavi bench.
