THE APPEAL BEING REFERRED TO LOK ADALAT ON 26/09/2016, COMING ON FOR CONCILIATION, THIS DAY, THE LOK ADALAT PASSED THE FOLLOWING:

# **CONCILIATION ORDER**

The matter was taken up in Lok Adalath.

- 2. Both side present.
- 3. Conciliation was held.
- 4. Learned counsels appearing for the claimant and the respondent-Insurance Company have filed a Joint Memo, settling the matter for Rs.2,00,000/- (Two lakhs rupees only) as enhancement in addition to what has been awarded by the MACT below.
- 5. Perused the said Joint Memo, the same is acceptable.
- 6. The respondent No.3 has agreed to deposit the said amount before the Tribunal, within Six weeks from the date of preparation of the award, failing which, the said amount shall carry interest at the

rate of 9% per annum from the date of default, till the date of deposit.

- 7. Parties are not entitled to any costs.
- 8. The terms of the joint memo is agreed to be full and final settlement between the parties with their free will and consent.
- 9. The enhanced amount is Rs.2,00,000-00. Out of which a sum of Rs.1,00,000-00 is to be released as per the terms in accordance with the original award. Remaining Rs.1,00,000-00 is to be apportioned among themselves and be kept in fixed deposit as per the original award.

The appeal is settled and stands disposed off on the above terms.

Draw the award, accordingly.
