THESE WRIT APPEALS ARE FILED UNDER SECTION 4 OF THE KARNATAKA HIGH COURT ACT, PRAYING TO CALL FOR RECORDS AND SET ASIDE THE ORDER DATED 30.01.2014 PASSED IN W.P.NO.201259-277/2014 BY THE SINGLE JUDGE.

THESE WRIT APPEALS COMING ON FOR ORDERS, THIS DAY, **H.G.RAMESH J.**, DELIVERED THE FOLLOWING:

### **J U D G M E N T**

#### **H.G.RAMESH, J.(Oral):**

At the request of the learned counsel appearing for the appellants, we have heard these appeals on merits and are being disposed of by this judgment.

2. All these appeals are directed against the common order dated 30.01.2014 passed by a learned Single Judge of this Court in a batch of writ petitions. By the aforesaid order, the learned Single Judge has dismissed the writ petitions which include the writ petitions filed by the appellants herein. The writ petitions were filed by the appellants for a direction to the respondent-University to approve the admissions made by the appellant-institutions to M.Ed. course for the academic year 2013-2014. The appellants also sought for a direction to the University to permit the students to appear for M.Ed. examinations scheduled during the academic year.

3. The learned Single Judge has dismissed the writ petitions *inter alia* on the ground that the appellant-institutions have not obtained *National Assessment and Accreditation Council Accreditation* and therefore the admissions made by the appellant-institutions cannot be approved and permission for the students to take the examinations also cannot be granted. It is relevant to refer to the following reasoning of the learned Single Judge in dismissing the writ petitions:

“4. *Undisputedly, petitioners’ institutions have not been accredited as per law. Institutions will have to comply with NCTE and NAAC requirement. In the matter on hand, none of the petitioners’ institutions have been accredited under NAAC (Grade-B) accreditation as required under rules and regulations. Since the petitioners’ institutions have not been complied with NCTE and NAAC requirements, those colleges are not recognized by the University for the year 2013-2014. If it is so, petitioners’ institutions cannot admit any student, inasmuch as, petitioners’ institutions are not even recognized by University.*

5. ....

6. *Be that as it may, since the petitioners’ institutions are not accredited as per law and as they are not recognized by the University, students should not have been admitted by the petitioners’ institutions. Consequently, admissions made by the petitioners’ institutions to M.Ed. course for the year 2013-2014 cannot be approved.”*

(Underlining supplied)

4. Learned Single Judge has also referred to the communications sent by the University to the appellant-institutions and after perusing the original records of the University has found that the University had not permitted the appellant-institutions to admit students for the academic year 2013-2014. The contention urged by the appellants to the contrary has been rejected.

5. The question that requires to be examined in these appeals is as to whether the appellant-institutions could have admitted the students to M.Ed. course for the academic year 2013-2014. As could be seen from the observations made by the learned Single Judge, none of the appellant-institutions have got NAAC accreditation with a letter Grade B under the new grading system developed by NAAC. In this context, it is relevant to refer to Regulation 8(5) of the *National Council for Teacher Education (Recognition Norms and Procedure) Regulations 2009*, framed under the *National Council for Teacher Education Act, 1993*, which reads as follows:

**“8. Conditions for grant of recognition.-**

.....

(5) *An institution that has been granted additional intake in Bachelor of Education and Bachelor of Physical Education teacher training courses after promulgation of the Regulations, 2005 i.e. the 13<sup>th</sup> day of January 2006 shall have to get itself accredited by National Assessment and Accreditation Council (NAAC), with a Letter Grade B under the new grading system developed by NAAC, on or before the 1<sup>st</sup> day of April, 2010 failing which the additional intake granted shall stand withdrawn with effect from the academic session 2010-2011. Similarly, all institutions having a **Master of Education and Master of Physical Education courses shall have to get NAAC Accreditation with at least a Letter Grade B on or before the 1<sup>st</sup> day of April, 2012, failing which Master of Education or Master of Physical Education recognition granted to the institutions shall stand withdrawn with effect from the academic session 2012-2013.***

(Emphasis & underlining supplied)

6. Admittedly, none of the appellant-institutions have got NAAC accreditation on or before 1<sup>st</sup> April, 2012. Hence, as per the regulation quoted above, the *recognition* granted to the institutions automatically stood withdrawn with effect from the academic session 2012-2013. Without recognition, the appellant-institutions should not have

admitted the students. We find no legal infirmity in the reasoning of the learned Single Judge in dismissing the writ petitions. The appeals are devoid of merit and are accordingly dismissed. However, this judgment will not come in the way of the appellant-institutions to apply/obtain NAAC accreditation (Grade B) and to request the respondent – University to hold examination for the students admitted to M.Ed. course for the academic year 2013-2014. It is for the University to consider the request in accordance with law and to take an appropriate decision in the matter. In view of dismissal of the appeals, all the interlocutory applications also stand dismissed.

***Appeals dismissed.***
