COURT MADE THE FOLLOWING:

**ORDER**

This petition is under Section 439 of Cr.P.C. seeking bail in respect of Crime No.121/2013 of M.B.Nagar Police Station registered on 26.08.2013 for the offences punishable under Sections 143, 147, 323, 341, 365, 504 read with Section 149 of IPC. After investigation the police have filed charge sheet against 17 accused persons for the offences punishable under Sections 143, 147, 323, 341, 365, 504, 302, 201 read with Section 149 of IPC in C.C.No.5952/2013.

2. The petitioner is arrayed as accused No.12 in this case. Having noticed that no incriminating material was seized at his instance. The case of this petitioner stands on the same footing to that of petitioners in Criminal Petition No.200108/2014 and connected matter who are enlarged on bail by the order of this Court. In this circumstance there is no impediment to allow the petition.

4. Accordingly, the petition is allowed. The petitioner is released on bail, subject to following conditions:

- i) The Petitioner shall execute personal bond for sum of Rs.1,00,000/- with two sureties for the like sum to the satisfaction of the jurisdictional Magistrate;
- ii) He shall mark his attendance periodically during the office hours in the first week of every month till beginning of trial and shall not leave the jurisdictional Court until the conclusion of the trial;
- iii) He shall not threaten or prevail upon prosecution witnesses and maintain themselves as law-abiding citizens.

Violation of above conditions entitles the Investigating Officer to move the concerned Court for cancellation of bail.
